THE BOARD OF DIRECTORS HAS DECIDED TO RUN A TEAM GAME ON WEDNESDAY EVENING, APRIL 26TH. A TEAM GAME CONSISTS OF FOUR-MAN TEAMS WHO COMPETE WITH EACH OTHER. THE FORMAT OF THE GAME IS YET TO BE DECIDED (SWISS TEAM, BOARD-A-MATCH, ETC). PLAYERS ARE ASKED TO SIGN UP AS PAIRS OR AS INDIVIDUALS. WHEN ALL THE PAIRS ARE ASSEMBLED, TEAMS WILL BE ASSIGNED BY THE DIRECTOR BASED UPON THE PAIR'S TOTAL MASTERPOINTS. FOR EXAMPLE, THE TOP SEEDED PAIR WILL BE ON THE SAME TEAM AS THE LOWEST SEEDED PAIR. THE SECOND SEEDED PAIR WILL BE TEAMED WITH THE NEST TO LAST SEEDED PAIR AND SO ON. THE CLUB WILL PROVIDE PIZZA AND SODA FOR THIS GAME. THE PIZZA WILL BE AVAILABLE BETWEEN 6:30 AND 7:00. THERE WILL BE NO INCREASE IN PLAYING FEES FOR THIS GAME. MEMBERS WILL PAY \$10.00 AND NON-MEMBERS WILL PAY \$15.00

RECENTLY THERE HAVE BEEN PROBLEMS WITH PLAYERS MAKING CLAIMS. THE ACBL RULES STATE THAT ONCE A CLAIM IS MADE, ALL PLAY STOPS AND THE DECLARER'S HAND IS EXPOSED. HOWEVER, IN ORDER TO PROTECT HIS CLAIM, THE DECLARER MUST TELL THE OPPONENTS HOW HE PLANS TO PLAY THE REST OF THE CARDS. IF THIS IS NOT DONE, THE DEFENDERS ARE ENTITLED TO A TRICK OR TRICKS ON A REASONABLE LINE OF PLAY. THE RULES ARE MORE STRINGENT WHEN THE DEFENDERS HAVE AN OUTSTANDING TRUMP. THESE RULES ARE MORE LIKELY TO FAVOR THE DEFENDERS. ALTHOUGH WE ARE ASKING PLAYERS TO BE CAREFUL WHEN CLAIMING, WE ARE ALSO ENCOURAGING DECLARERS TO MAKE CLAIMS WHEN IT IS OBVIOUS THAT THEY HAVE ALL THE REMAINING TRICKS. FOR INSTANCE, IF YOU HAVE ALL THE REMAINING TRUMP THERE IS NO POINT IN PLAYING EVERY SINGLE CARD.
